## ***Background***

The Environmental Planning and Assessment (EPA) Caucus of the Réseau Canadien Environmental Network (RCEN) is an active body of environmental assessment practitioners, community-based educators, academics, activists, biologists, lawyers, policy analysts, private consultants, and other concerned citizens. All of these individuals have first-hand experience with environmental assessment (EA) in Canada and they share a common vision of truly effective environmental assessment in this country.

The caucus provides input and feedback to all member groups and, via the weekly *RCEN Bulletin*, to all members of the network. Through face-to-face meetings and regular communication, the caucus is able to bring forward a strong analysis of the many facets of environmental assessment in Canada. This allows caucus members to inform the environmental community about developments and issues connected with the *Canadian Environmental Assessment Act* and its regulations, and allows member groups to fit local initiatives into larger policy contexts.

The strong communication between diverse member groups located in all regions of Canada, and the energy, knowledge, and "on the ground" experience of its members make the caucus the most substantive and dynamic network of environmental assessment expertise in Canada today. A fundamental belief of the caucus is that environmental assessment must contribute to sustainable development and result in protection of the environment.<sup>1</sup>

Members of the EPA Caucus have participated for nearly two decades in a range of EA-related consultations with various industries and government agencies at all levels, including the Canadian Environmental Assessment Agency's Five-Year Review processes, and have considerable credibility in the EA milieu in Canada.

### **Purpose of this Report**

It has become evident over the past number of years that citizens and civil society groups are facing increased barriers to participating in environmental assessment processes to the extent that existing laws (federal, provincial, and territorial) allow. We believe this is due to the various effects of "down-sizing," "streamlining," and harmonisation policies by all levels of government in Canada; to greater demands on funding sources for all volunteer-based organisations; and to "globalisation" on a macro scale.

In 2004, the caucus put out a call to groups across Canada to determine if there was a need for citizens to get help with environmental assessments in their areas. The response so far has been tremendous and shows a high level of concern about the efficacy of the various environmental assessment processes throughout Canada. Certainly there is a need for assistance greater than the current ability of organisations to provide.

At an EPA Caucus meeting in October 2004, it was decided that the caucus would carry out initial research into the feasibility of establishing an Environmental Assessment Legal Action Fund that would serve as a "clearinghouse" of funding for citizens and civil society groups seeking funding for EA-related actions—in the federal, provincial, and territorial jurisdictions.

To this end, the Strategic Legal Actions Committee, as a subgroup of the EPA Caucus, is exploring the creation of an entity that can assist the public in two major ways (a) to better understand EA legislation they may be dealing with, and (b) to participate in EA processes in which they believe they have some interest, whether or not they have “legal standing.” Concurrently, we are looking at existing organisations, both nationally and regionally, with whom we could partner—or form a network of partnerships—to deliver these services.

There already exist a few organisations in Canada that do work of this nature, or work that is closely related to it (e.g., West Coast Environmental Law Association, Sierra Legal Defence Fund). These, however, do not have the capacity, funding, and in some cases the “jurisdictional ability” to meet the current needs across the entire country. To do so, would require major expansion of their types and levels of assistance to the public.

## ***Funding/Organisational Options***

The writer was asked to research and report on the potential to secure funding to enable citizens and civil society groups to participate in EA legal challenges. This report describes two possible models to receive such funding. It includes sample correspondence for seeking advice on a model and for sending directly to potential funding sources.

Finding a source of funding either for a standalone entity or for services to be handled by a consortium or network of organisations with the necessary expertise is proving to be difficult, as surmised. Very few funding sources are able, due to the nature of “charitable donations” regulations, to fund what is seen as “advocacy” work for strictly litigation purposes. The best scenario is to create an organisation that can be funded to provide legal advice and other services, including litigation, for citizens and civil society groups to enable them to challenge an environmental assessment process (or lack of one).

Some of the activities provided by such an organisation could include:

- > widespread public education on the rights of citizens to challenge government decisions on how environmental assessment is—or is not—being carried out for a given project
- > assisting (including advising) citizens or civil society organisations that would otherwise be unable to participate in an environmental assessment process either because of financial constraints or because the process restricts (or in some cases, forbids) their participation
- > how (or if) the process is reported out to members of the public having an interest in the project being reviewed

## ***Organisational Models***

The Strategic Legal Actions Committee is looking for organisational models, as described above. The two best models found so far are:

1. **Environmental Dispute Resolution Fund (EDRF)**, administered by West Coast Environmental Law Association, a not-for-profit law centre based out of Vancouver, British Columbia. This program is not focused specifically or solely on environmental assessment legal challenges, and is only available to citizens or (more usually) to organisations in BC.

The purpose of the West Coast Environmental Dispute Resolution Fund (EDRF) is to promote sustainable development by assisting individuals or non-profit organizations to resolve disputes regarding protection of the environment or community participation in environmental decision-making. Through the Fund, established in 1989 with the generous support of the Law

Foundation of British Columbia, West Coast provides financial assistance to citizens and groups who need legal assistance to resolve environmental issues.

Groups can retain private lawyers, who may provide a legal opinion on an issue, represent the group in negotiating a solution to an environmental dispute, or argue a case in court or before a tribunal. The Fund provides financial assistance to concerned citizens and groups for three purposes:

- > litigation or participation in administrative tribunals
- > participation in alternative methods of dispute resolution, such as negotiation, mediation, or multistakeholder consultation
- > experts' fees to hire scientific experts, such as fisheries biologists or hydrologists, to provide an expert opinion in relation to a case supported by the Fund

Resolving an environmental dispute may involve many dimensions—legal, political, or educational—each of which involves time and resources. Legal tools are expensive, but when used effectively can mean the difference between solving the environmental problem and not. The EDRF provides funding for legal support for organizations, or in some cases individuals, facing significant environmental challenges. An EDRF grant can cover the hourly fees of a lawyer (at least partially on a “pro bono” basis). Where necessary, an EDRF grant may also cover the fees of a professional expert.

The EDRF values the use of alternative dispute resolution (ADR) in resolving environmental conflicts, including negotiation, mediation, and arbitration, but all parties should have agreed to participate in the ADR process.

The EDRF is primarily designed to offer legal assistance for work in the public environmental interest. Unless the EDRF has granted special permission, expenses must be those incurred by the lawyers or experts directly. The fund does not pay for any administrative expenses. Granting decisions are made on a monthly basis by a committee.

**2. Farmers Legal Action Group (FLAG).** This is a standalone American group. FLAG “provides legal support, impact litigation, and legislative technical assistance to family farmers.” The following information is from FLAG’s website: <http://www.flaginc.org/index.htm>

FLAG is a not-for-profit law centre that provides legal services to family farmers and their rural communities... FLAG’s work includes issues of concern to family farmers and ranchers: the need for more sustainable agriculture, corporate concentration...in the poultry and livestock industries, contract farming, race discrimination in USDA programs, accountability in government support programs, and legal help for farmers seeking to develop value-added enterprises. FLAG uses some combination of the following four methods to help its clients:

- > **Education.** FLAG conducts seminars around the country on issues facing family farmers. These seminars are attended by farmers and their advocates and lawyers. To complement its trainings, FLAG also produces user-friendly books, booklets, articles, charts, and videotapes.
- > **Backup Support.** FLAG provides a broad range of support services each year to farm advocates, rural legal services programs, private attorneys, and farm organizations. These include explaining complex laws, providing timely information regarding changes in the law, providing research on important legal issues, reviewing and analysing cases, co-counselling cases, and providing tailor-made legal education materials and trainings.

- > Impact Litigation. FLAG undertakes strategic litigation—usually class action lawsuits—to change important areas of law that will have an effect on a large number of family farmers.
- > Administrative and Legislative Technical Assistance. FLAG provides administrative and legislative technical assistance to its clients by submitting formal comments on proposed agency regulations, testifying before federal and state legislative bodies, and assisting client organizations in their attempts to draft legislation.

Other potential models include Sierra Legal Defense Fund in Canada, and EarthJustice in the United States (see descriptions below).

## ***Potential Sources of Funding***

Appendix 1 contains an annotated list of potential funding sources, with contact information, program areas, goals, etc. Some of these are issue-specific, but include legal actions of some kind; others are specific to certain regions of the country. A few are listed for information purposes only. It should also be noted that a number of US-based foundations have had to significantly restrict funding Canadian projects since the “9/11 disaster” in 2001.

## **Sample letters to potential funders for information or advice about funding or funding models**

### Letter #1 (seeking information)

Dear \_\_\_\_\_:

The Environmental Planning and Assessment Caucus, a body created under the auspices of the Canadian Environmental Network (CEN) and composed of members of member groups of the CEN, is seeking advice on funding—and funding models—to enable citizens and civil society groups to either seek legal advice or undertake legal actions in regard to environmental assessment—federal, provincial, or territorial.

Members of the EPA Caucus have participated in a range of EA-related consultations with government agencies at all levels, including the Canadian Environmental Assessment Agency's Five-Year Review, for over a decade and have considerable credibility in the EA milieu in Canada.

It has become evident over the past number of years—due, we believe, to the various effects of government “down-sizing,” and “streamlining” or harmonisation policies—that citizens and civil society groups are less able to participate in environmental assessment processes to the extent that the law allows (federal and provincial).

To this end, we are exploring the usefulness of creating an entity that can assist the public both in better understanding EA legislation they may be dealing with and to participating in EA processes. Alternatively, we are seeking existing organisations, either national or regional, with whom we could partner.

We would appreciate your considered advice—whether on funding or on a possible conceptual model—for an entity to acquire and manage funds specifically for EA legal challenges in Canada.

### Letter #2 (for information on whether or not a foundation will fund legal actions)

Dear \_\_\_\_\_:

The Environmental Planning and Assessment Caucus, under the auspices of the Canadian Environmental Network, is seeking funding to enable citizens and civil society groups to seek legal advice and/or undertake legal actions in regard to environmental assessment—federal, provincial, or territorial.

Members of the EPA Caucus have participated in a range of EA-related consultations with various industries and government agencies at all levels, including the Canadian Environmental Assessment Agency's Five-Year Review processes, for over a decade and have considerable credibility in the EA milieu in Canada.

It has become evident over the past number of years—due, we believe, to the various effects of government “down-sizing,” and “streamlining” or harmonisation policies—that citizens and civil society groups are less able to participate in environmental assessment processes to the extent that the law allows (federal and provincial).

To this end, [whatever charitable entity results from this report] we would like to know if your [foundation, agency, corporation] is interested in helping fund it. If your policies permit funding legal challenges, could you please advise us further on your funding application process.

## ***Conclusion***

Citizens and civil society groups are facing increased barriers to participating in environmental assessment processes throughout Canada, whether in federal, provincial, or territorial jurisdictions. Their need for legal services has grown considerably. The legal needs of some individuals and organisations can fit within the funding guidelines of the few entities that provide direct legal services described in the previous sections. However, capacity is limited and does not meet the current, let alone the future, needs.

Other individuals and groups find themselves having to take the more difficult route of applying to government agencies (e.g., CEAA's public participation section or Environment Canada's "EcoActions" program) or to philanthropic organisations. This results in a piecemeal and very limited rate of success.

The Environmental Planning and Assessment Caucus of the CEN, notably the Strategic Legal Actions Committee, has determined there is a need for the creation of a dedicated organisation (or the augmentation of an existing organisation) that has the capacity to meet the local, regional, and national needs of the public to engage in environmental assessment legal actions.

The SLA Committee is seeking advice on conceptual models and on funding sources for such an entity. In order for an organisation to receive funding, it will need to get charitable status. This takes time and can be costly. It may be desirable to work in partnership with an organisation that already has that status.

## **Appendix 1: Potential Funding Sources for Environmental Assessment Challenges**

The first eleven in the list below were collected by the Environmental Law Centre (in Alberta) in March 18, 2004. Note that numbers 3, 5, and 7 are not granting organisations, but are good sources of information specifically for the purpose of obtaining funding for environment-related projects. This is the Arctic Futures Fund of CARC, the Canadian Arctic Resources Committee. Should the environmental assessment challenge be in the Arctic, it may be an option. "The interest and dividends generated by *Arctic Futures Fund* is used by CARC to pay for all manner of activities including research, advocacy, public information, publishing and litigation consistent with the belief that economic development in the Arctic must be environmentally and culturally sustainable and equitable."
3. **Directory of Funding Sources for Environmental NGOs in Central and Eastern Europe**

This is a Directory of Funding Sources for Environmental NGOs in Central and Eastern Europe. It is a searchable database that offers information about 164 different funding institutions. It is likely only useful for projects in that geographic area, although if proposed by Canadian companies the projects must still abide by Canada's environmental assessment processes.  
"The directory covers 15 CEE countries in which the REC is active and also some Newly Independent States. The directory presents a range of funding institutions focusing on environmental activities as well as support to non-governmental organisations."

This is the Participant Funding Program of the Canadian Environmental Assessment Agency. Individuals and non-profit organizations interested in participating in environmental assessments may receive limited funding.

This is the website of the Canadian Environmental Grantmakers Network, "a membership group of private, community, public, and corporate foundations, and government and corporate funding programs that give grants in support of the Canadian environment." CEGN has created a database that provides a profile of environmental grantmaking in Canada. There are currently two products of the database:  
Canadian Environmental Grantmaking Sector Profile  
The profile provides aggregate data on the size and characteristics of the Canadian environmental grantmaking sector. This will help to identify sector-level needs and gaps, to generate discussion and support collaboration among grantmakers and others, and to provide individual

grantmakers with a context for their activities. It will serve as the base for a variety of further research, consultative and communications projects.

Canadian Environmental Grants Database: Interactive Search

Through CEGN's website, members and others have access to an interactive search component of the database. The database serves as a practical resource for individual grantmakers by providing information for day-to-day work and strategic funding decisions, and in identifying other grantmakers who may be sources of information or potential partners on specific issues. ## **Appendix 2: Compilation of Communications**

Below are “copy-and-paste” portions of emails sent to people and organisations or foundations requesting information, and their responses (there were very few responses, due in part, to the requirement of many potential funders.

### **1. To Kathryn Townshend of the Canadian Environmental Grantmaking Network:**

I have been asked by the Environmental Planning and Assessment Caucus, made up of members of member groups of the Canadian Environmental Network, to write a report on possible funding sources for Environmental Assessment (EA) legal challenges. I find your website very interesting and useful for understanding a national profile of ENGOs, by the way. I have done a considerable amount of raising funds for ENGOs and other community-based organisations from corporate and government agency sources, and in all the years I've been doing this (as a volunteer), I have not found any grant-maker that seems to like funding legal actions taken on by citizens and citizen organisations. Do you know if this is changing in Canada? Have you got any suggestions of grant-makers that I might contact?

A number of the member organisations of the caucus are registered charities, and all groups represented are registered societies in their province of origin. Most are small to medium-sized groups and the members are from every province and territory in Canada. The idea is to form some type of consortium, committee, or standalone organisation that collects and administers funds to citizens or citizen groups who find themselves in need of legal advice regarding challenging such things as the scope or quality of environmental assessment of a project in which they would have standing.

Any ideas on where I could look for a grant-maker, or group of grant-makers who may be interested in this?

### **Her reply:**

While it's not within CEGN's mandate to give specific suggestions of potential funders, here are some general comments that may help. First ... the 2002 National Overview... shows grants by activity funded. It indicates that 1% of the total environmental grant dollars in 2002 went to grants supporting the activity of litigation/legal work. Any grants on the subject of environmental assessments would fall within this category. Although I don't have specific info on grants to environmental assessments, I would estimate that there were perhaps a handful that dealt specifically with EAs.

I don't believe that any funders identify the funding of legal challenges as a specific objective, but certainly some support is going toward legal research, participation in legal reviews, as well as more general support of charitable organizations that do provide legal advice, support, and representation on environmental cases. I think that as foundations continue to explore ways to increase their effectiveness at supporting environmental change, that policy/legal solutions will be... a growing area of support. However, foundations are bound by restrictions on their support of "advocacy" activities, so they will look closely at the type of projects they support with this in mind (For example, some may be comfortable funding legal research, but not an actual court case.)

There are certainly quite a few organizations that currently provide legal advice and information to citizens... looking at each group's list of supporters will give you a list of funders who have an interest in supporting environmental law projects... Good luck with your project.

**My follow-up response to her:**

Thank you so much for your reply. You are correct in assuming that our caucus includes people who are lawyers, legal researchers, and members of CELA, WCELA, SLDF, CIELAP, and other similar organisations. Individually, none of these has the capacity to assist the growing number of citizens and citizen-based organisations with the kinds of legal challenges that are increasingly arising around the issue of environmental assessment and strategic EA. Many funders, as you say, are cautious about this kind of advocacy work. As well, I need to become more clear on exactly what kind of entity our caucus is contemplating. Your response has given me good food for thought. Thank you.

**2. To Robert Gibson at University of Waterloo:**

The EPA caucus of the CEN has asked me to write a report on the availability of funding sources for those challenging various aspects of environmental assessment. I came across an article you co-authored in the *Journal of Environmental Assessment Policy and Management*, Vol. 3, No. 3 (Sept 2001), titled "Strategic Environmental Assessment as a means of pursuing sustainability: ten advantages and ten challenges," with Kirk Stinchcombe. I couldn't access the entire article because I'm not a subscriber to the Journal, and don't know if it would be useful anyway. What I'm contacting you about is to find out if you know of any funding (or potential) sources specifically for legal challenges?? Could you please let me know, or where would be good places to look for funding?

**His reply:**

I can send you the article, if you wish. However, it contains nothing on legal challenge funding. I've no particular insights on that topic. The sources I know about are the usual ones - those who support Env Defence, Sierra Legal, and the various environmental law clinics, such as WCELA and CELA.
